PURPOSE

For the Major Projects Committee to consider the proposed schedule of committee meeting dates for 2016.

EXECUTIVE SUMMARY

In order to assist with forward planning for all Elected Members, management and staff, a schedule of meeting dates has been prepared for the Major Projects Committee, ensuring synergy between meeting dates and the flow of information and decision-making.

It is recommended the Major Projects Committee adopts the meeting dates and times for the Major Projects Committee of the City of Joondalup to be held at the Joondalup Civic Centre, Boas Avenue, Joondalup.

BACKGROUND

The Major Projects Committee was established at the Special Council meeting held on 3 November 2015. The role of the Major Projects Committee is to:

- oversee the progress of the Ocean Reef Marina, the Joondalup City Centre Office Development, the Joondalup Performing Arts and Cultural Facility and other major strategic capital projects as identified from time to time
- make recommendations to Council on various elements of the projects within the role of the Major Projects Committee, including but not limited to:
 - project scope
 - o design elements and core project components
 - development models and financial structures
 - on-going management and utilisation models.

The proposed 2016 schedule of Council meeting dates is based on the format used in recent years. That is, a monthly meeting format with Strategy Sessions held on the first Tuesday of each month, Briefing Sessions held on the second Tuesday and Council meetings on the third Tuesday.

This enables committee meetings to be scheduled on the Monday, Tuesday or Wednesday of weeks one, two and three so as to minimise potential conflicts with other Council activities and provide a 'meeting-free' week in the fourth week of each month.

It is preferable to hold committee meetings in the first week of the month, thereby enabling committee recommendations to be listed in the Briefing Session agenda and subsequently the Council meeting agenda, however this may not always be possible due to other scheduled meetings.

DETAILS

The Major Projects Committee is a new committee that will oversee the progress of a variety of landmark projects within the City of Joondalup. Meetings of this committee may need to be held on an 'as-needs' basis, due to the nature and timing of decisions needed for these significant projects,. However, to ensure ongoing progress reports are provided to Elected Members and enable timely decisions to be made, it is suggested the Major Projects Committee meets bi-monthly, on the Monday of the first week of the month.

The proposed meeting day / date / times are as follows:

- Monday 1 February 2016, commencing at 6.00pm
- Monday 4 April 2016, commencing at 6.00pm
- Monday 13 June 2016, commencing at 6.00pm
- Monday 1 August 2016, commencing at 6.00pm
- Monday 31 October 2016, commencing at 6.00pm.
- Monday 28 November 2016, commencing at 6.00pm.

The first Monday in June is the WA Day public holiday, therefore it is proposed to hold the meeting the following week on 13 June. The December meeting schedule is typically held one week earlier to accommodate the Council recess and the December meeting has been scheduled on Monday 28 November accordingly.
