CONFIRMATION OF MINUTES

A meeting for the Joondalup North YAC did not occur on May 20, 2002. Members of this Youth Advisory Council were invited to attend this meeting.

4. Road safety Project Presentation

Following discussion regarding the terms of reference for the Youth Advisory Council, it was suggested that these applicants be invited to apply for a position on the Youth Advisory Council. Following an interview with a panel of Youth Advisory Council members, suitable members could be invited to join the Youth Advisory Council as associate members. They would then have to reapply through the normal process. Members agreed that this would be the best course of action.
