### **Selection Summary:**

Suppliers offered five makes of vehicles. The Mitsubishi Magna was offered as the 3.0 and 3.5 litre Executive model, together with the 3.5 litre Advance model.

A whole of life costing comparing the five makes of vehicles offered was undertaken to compare the whole of life costs. The Ford Falcon Forte was found to be the most cost effective vehicle tendered after considering the estimated resale values at two years of age and estimated fuel consumption at 40,000kms of travel.

The whole of life costing evaluation is used to identify the best value vehicle make and then the lowest cost changeover is used to select the supplier. The Ford Falcon Forte tendered by Backshall Ford was found to be the lowest cost vehicle offered after trade of the existing council vehicle.

The tenders submitted for outright purchase and supply only were examined and it was determined that there was no financial advantage for the City to accept any of these Tenders.

The market for this class of vehicle is dynamic as indicated by the predicted resale values and ability to supply vehicles within reasonable times. The latest residual value guide indicates that the Ford Falcon Forte will have a higher future resale value compared to the Magna Executive. This is a marked change in value from the previous quarter when a two year old Ford Falcon residual value was substantially less than the present quarter residual value. The reason for this variation is due to the change of Falcon model. After considering the higher resale value, the Ford Falcon Forte will be marginally less expensive than the Magna on whole of life basis.

The 3.0 litre Mitsubishi Magna Executive as tendered by Melville Mitsubishi offered the lowest change over price but is predicted to have a resale value below the Ford Falcon Forte and consequently is not recommended for purchase.

The next lowest changeover were the Tenders received from Rohanna Pty Ltd trading as Skipper Mitsubishi and Melville Mitsubishi for the supply of the 3.5 litre Magna Executive which is predicted to have a resale value below the Ford Falcon Forte and consequently is not recommended for purchase.

The 3.0 litre Mitsubishi Magna Executive, as tendered by Wanneroo Mitsubishi offered the fourth lowest change over price but is predicted to have a resale value below the Ford Falcon Forte and consequently was not recommended for purchase.

The methodology used in the whole of life comparison was reviewed by the R.A.C. and confirmed to be sound.
