#### 5. GENERAL BUSINESS

## 5.1 ART COLLECTION

Rie Heymans explained the collection's profile was to collect quality artworks by Western Australian artists that reflect the lifestyle of this particular period and region.

Cr Barnett raised the issue of security of the collection and suggested that the City investigate the purchase of security clasps for those artworks in public spaces.

# 5.2 ART EXHIBITIONS AND AWARDS

James Boyd outlined the aims and objectives of the City of Joondalup's annual exhibitions, the Community Art Exhibition and The Invitation Art Award.

Rie Heymans confirmed that the City of Joondalup's annual exhibitions are of the highest standard of all Local Government coordinated exhibitions. In order to maintain the high standard of the exhibition only artists who have had solo exhibitions of a high standard with established galleries would be considered for invitation to exhibit.

Mark Stanton outlined the community consultation that had been carried out in July with artists from the local arts community, and the positive feedback that had been received for the current visual arts program.

The dates for 2001 art exhibitions were confirmed:

Community Art Exhibition Thurs 10 May - Mon 28 May 2001 Invitation Art Award Thurs 30 August - Mon 17 Sept 2001

Cr Barnett recommended that the Art Award and winning artworks be represented on the Council web site. Belinda Cobby, the Arts Project Officer, is currently developing content for the City's web site that represents the cultural activities of the region.

The winning artwork of the 2000 Invitation Art Award by Richie Kuhaupt requires to be installed within Council premises and potential sites were discussed and located within the Civic Centre.

It was agreed that the artwork "Woman in Red" should be displayed in the foyer of the City of Joondalup Civic Centre.

# 5.3 PURCHASE OF ARTWORKS

## 2 MEMBERSHIP

The Art Collection Working Party shall consist of the following members:

#### 4 MANAGEMENT

## 4.1 Terms of Appointment.

All appointments to the Working Party shall be by nomination and shall be endorsed by the Council. The term of office shall be for twelve months from the first Council meeting in June.

# 4.2 Chairperson

The Chairperson shall chair the meetings. In the absence of the Chairperson the meeting shall appoint an Acting Chairperson for that particular meeting.

# 4.3 <u>Meetings</u>

Meeting occur as required.

# 4.4 Quorum

A quorum will be by simple majority.

# 4.5 <u>Voting</u>

At the meeting each member of the Working Party shall be entitled to one vote and, in the case of equality of voting, the Chairperson shall have the casting vote.

## 4.6 Minutes

Minutes shall be made of all meetings. A copy of confirmed minutes shall be forwarded to the Committee Clerk. Minutes of all Working Party meetings shall be forwarded to all members at least seven days prior to the following meeting.

## 4.7 Powers of Council

Nothing herein shall restrict the powers of Council.
