




Acknowledged. Whilst it is appreciated that some concern for child safety can be validated by having the PAW linked to the road, it is considered the risk would be similar to that expected for all housing in suburban area connected to the road system.
			2. Graffiti is a minor problem. In all the time I have used the PAW I have not witnessed any acts of graffiti. No attempt has been made by abutting landowners to clean up the graffiti.	2. Noted.
