**1. WELCOME AND ELECTION OF CHAIRMAN**

## **4. ITEMS OF BUSINESS**

### **4.1 Terms of Reference**

The Terms of Reference was submitted and noted that Council had resolved that the purpose of the committee is as follows:

Purpose: Investigating, developing and making recommendations for the construction of skateboard facilities in the City of Joondalup

It was noted that the Terms of Reference will be submitted to Council to endorse changes to the membership.

### **4.2 Proposed Skatepark Sites - Public Meetings**

Cr Hollywood gave an overview of the Skatepark Committee and the public meetings held to discuss the three proposed skatepark sites. The outcomes of the meetings were as follows:

#### **1. MacNaughton Park, KINROSS**

There were 26 adults and 35 children present. People presented arguments for and against a skatepark for this location. The motion was put to the vote: 16 in favour, 10 against.

#### **2. Kanangra Park, GREENWOOD**

Approximately 80 people attended this public meeting. People presented arguments for and against a skatepark for this location. The majority were against a skatepark going in this park. However 42 were in favour and 11 against the idea for a skatepark to be constructed in another location within the Greenwood area. A number of alternative sites for a skatepark were suggested within the area.

#### **3. Lexcen Park, OCEAN REEF**

Approximately 80 people attended this public meeting. People presented arguments for and against a skatepark for this location. A representative from Ocean Reef Residents Association supported the idea of a skatepark being constructed in Mirror Park, Ocean Reef. The majority were against a skatepark going in this park, however 27 were in favour and 17 against the idea for a skatepark to be constructed in another location within the Ocean Reef area. A number of alternative sites for a skatepark were suggested within the area.

## **5. GENERAL BUSINESS**

### **5.1 It was agreed that the following actions would be undertaken:**

- Hold a site meeting at MacNaughton Clubrooms, Kinross, with members of the Committee and interested residents.
- Assess suggested alternative sites for the Ocean Reef and Greenwood areas.
- Arrange a tour of assessed sites for the Committee.
