#### **1.        CONFIRMATION OF MINUTES**

MOVED Cr O'Brien, SECONDED Cr Mackintosh that the Minutes of the Skatepark Committee Meeting held on 23 May 2001, be confirmed as a true and correct record.

#### **2.        PUBLIC MEETINGS – OCEAN REEF AND GREENWOOD**

Mr Vic Harman, representing the Ocean Reef Residents Association, outlined the history of Mirror Park, Ocean Reef and advised the Association supports the proposed skatepark for Mirror Park.

Cr Hollywood gave an overview of the public meetings held to discuss the two proposed skatepark sites in Ocean Reef and Greenwood. The outcomes of the meetings were as follows:

### **Mirror Park, Ocean Reef**

People presented arguments for and against a skatepark for this location. The majority of people were in favour of skatepark going in this park, 16 for and 9 against. Also, 16 were in favour and 8 against the idea for a skatepark to be constructed in an alternative location within the Ocean Reef area.

### **Penistone Reserve, Greenwood**

People presented arguments for and against a skatepark for this location. The majority were against a skatepark going in this park, 2 for and 24 against the idea. The majority were also against the idea for a skatepark to be constructed in an alternative location within Greenwood, 7 for and 16 against.

## **3. MACNAUGHTON PARK, KINROSS – CONCEPT DESIGN MEETING**

Cr Hollywood outlined the initial Skatepark concept design meeting for MacNaughton Park, Kinross that included representatives from the Skate Association of Western Australia (SKAWA).

## **4 FUTURE SKATEPARK FACILITIES**

Cr O'Brien detailed outcomes of a meeting with Margaret Quirk MLA, Member for Girrawheen, for a joint venture between the City of Joondalup, City of Wanneroo and the City of Stirling, for a proposed skatepark facility to be located in Liddell Reserve, Wanneroo.

An extensive discussion ensued with various options for the development of skate facilities identified.

## **2. GENERAL BUSINESS**

It was agreed that the following actions would be undertaken:

- Arrange a meeting with the Greenwood High School Principal and President of the Parents and Citizens Association to discuss the feasibility of a skatepark located within the school grounds.
- Contact Churches of Christ Sport and Recreation Association to discuss the feasibility of a skatepark located at Warwick Leisure Centre.
- Cr Hollywood and Cr O'Brien to meet with the Mayor of the City of Wanneroo and local Ward Councillors in relation to the Liddell Reserve proposal.
- Research the potential demand from young people for the Elcar Park skatepark proposal.
- Continue planning the MacNaughton Park, Kinross skatepark facility.
- Place the Mirror Park, Ocean Reef skatepark proposal on hold until above action has been completed.
