Roadwise Committee Member for Hillarys Primary School P & C Objection	<ul style="list-style-type: none"> • PAWs are seen as the “safe routes to school” and avoid children using streets with heavy school traffic • P&C have worked tirelessly to encourage students and parents to walk to school rather than use vehicles • PAW closure would discourage this
Residents in Drinan Place 3 Submissions Objection	<ul style="list-style-type: none"> • PAW closure is likely to encourage car use • Even further car use likely when the new shopping center is developed on Waterford Drive • Proposal should be deferred until the shopping center is developed to establish PAW usage patters • Council’s policy on greenhouse gas emissions needs consideration when making decision on proposal • Family of five would be greatly inconvenienced by closure of the PAW • One of the attractions of Hillarys area is the maze of PAWs, making it a pleasant walk to surrounding parks
Resident in Fawkner Gardens Objection	<ul style="list-style-type: none"> • PAW system was planned as part of subdivision and gives area community feel • Adjoining landowner to PAW should consider cutting back a tree to help with sight lines in PAW • Adjoining landowner should consider raising fence heights
Resident in Drinan Place Supporter	<ul style="list-style-type: none"> • Also close PAW between Drinan Place and Watt Street • Users of the above PAW discard rubbish • Repeated damage to property • PAW notification signs pushed over during advertising period • Traffic safety concerns as youths on bikes and skateboards race down PAW having little regard for traffic in Drinan Place
Resident in Rossiter Heights Supporter	<ul style="list-style-type: none"> • Also close PAW between Gipps Close and Murray Drive • Masses of youth frequent the above PAW • Due to above problems sympathises with applicants of subject PAW
Resident in Drinan Place Supporter	<ul style="list-style-type: none"> • Supports closure of both PAWs on Agenda • For effectiveness the PAW between Drinan Place and Watt Street should also be closed or all problems will be redirected to it • Trees being pulled out, a rubbish bin overturned on his drive and eggs thrown at neighbours’ front doors
