The Chairperson declared the meeting open at 9.35 am.

2. CONFIRMATION OF PREVIOUS MINUTES

MOVED Kevan Rowe, **SECONDED** Mayor Carlos that the minutes of the meeting held on 20 August 2003 is a true and accurate record.

3. GUEST SPEAKER – COMMONWEALTH CARELINK CENTRE

Karena Gilmore and Val Abery introduced themselves to the Committee.

Val advised the meeting that the office of the Commonwealth Carelink Centre are information centres that had been developed to assist older people, people with disabilities and those who provide care and services. Val advised that the network of Commonwealth Carelink Centre was established in 2001 and that there are now 65 'walk-in' shop-fronts and over 90 access points throughout Australia that are conveniently located near or within shopping centres. Karena spoke about the Centres providing free and confidential information on community aged care, disability and other support services available locally, intrastate or anywhere within Australia

Karena and Val then gave a power point presentation to the Committee

Kevan Rowe asked about the Commonwealth Privacy Act and how it affected the operating of the Commonwealth Carelink Centre.

Val explained that information permitted under the Commonwealth Privacy Act was retained by the Commonwealth Carelink Centre.

4. GENERAL BUSINESS

4.1 Directory for Seniors and People with a Disability

Acting Manager Community Development Services advised the meeting that the Directory was unable to be mailed out due to the Privacy Act, however advertisements will be placed in the Community Newspapers and the Directory will be available at all Libraries and Leisure Centres.

Cr O'Brien suggested that the Committee seek a deputation from the local member of Moore Dr Mal Washer.

MOVED Cr O'Brien, **SECONDED** Allyn Bryant that a deputation be sought to clarify the restrictions of the privacy act.

4.2 Seniors Expo

Acting Manager Community Development Services advised that the Seniors Expo will be held on the 27 and 28 October 2003 at Lakeside Shopping City and Warwick Grove Shopping Centre. A prize of \$300 worth of home maintenance is being offered to bring people to the Expo.

Cr Walker asked why the Seniors Expo was not being held at the Whitford City Shopping Centre. Acting Manager Community Development Services explained that there was an insurance liability issue with holding the Expo at the Whitford City Shopping Centre.

Lew asked whether the Directory for Seniors and People with a Disability would be printed in time to be displayed at the Seniors Expo. Acting Manager Community Development Services advised that the printing of the directories had been held off due to the uncertainty of the numbers to be printed. Lew stated that this opportunity would be too good to miss. Acting Manager Community Development advised that she would ask Community Development Officer, Yvette Peterson to endeavour to have them printed as soon as possible. Acting Manager Community Development Services suggested that details could be taken for people who would like a Directory sent to them.

4.3 Retirement Villages

Mayor Carlos advised that at a previous Seniors Interests Meeting he spoke about a representative from the St Ives Retirement joining the Seniors Interests Advisory Committee and asked what the outcome had been.

Acting Manager Community Development Services advised that there is a certain procedure to be followed to invite a new member to join the Committee which includes the vacancy to be advertised. Kevan Rowe advised that the Terms of Reference would need to be changed before this could take place.

MOVED Kevan Rowe, **SECONDED** Allyn Bryant to put forward a recommendation to change the Terms of Reference to allow a vacancy to be advertised for the recruitment of a person who could represent the issues regarding accommodation for seniors.
