# 3. BUSINESS ARISING FROM THE MEETING HELD ON THE 27 NOVEMBER 2002.

#### 4. GENERAL BUSINESS

4.1 Ecoscape Coastal Plan Project Identification

K. Armstrong gave some background information about the Conservation Advisory Committee's involvement in selecting a coastal rehabilitation project to be undertaken in 2003. He then went onto outline a proposal from Council to rehabilitate the dunal system between Merrifield Place Mullaloo and Whitfords Avenue.

There was discussion about site selection and methodology. M. Norman said that some of the funds from the \$150,000 be listed for the project be retained in case of fire damage to other dunal systems. K. Clarke asked Council Officers about the coastal rehabilitation funding being applied for by Council from the Perth Biodiversity Project. D. Cluning gave an over view of the submission.

J. Wood proposed the following motion;

'That the Conservation Advisory Committee endorse the cities proposal to allocate budgeted amount of \$150,000 to rehabilitate the dunal system between Merrifield Place and Whitfords Ave Kallaroo. This being one of the priority areas listed for rehabilitation in the Joondalup Coastal Foreshore Natural Areas Management Plan.

### 5.7 Coastal Fencing

S. Magyar requested that the fencing on Whitfords Ave adjacent to Whitfords Nodes be repaired, as well as installing fencing on the western side of Ocean Reef Road opposite Swanson Way Ocean Reef. D. Cluning said Council will endeavour to complete these projects in the near future. He added that funding had been sourced to complete a number of fencing projects on foreshore reserves.
