Late Vacancy – Air Quality Coordinating Committee 05-011-02-0001

The Air Quality Coordinating Committee is seeking nominations from Elected Members and Serving Officers for the positions of Member and Deputy Member. The Committee was established by the Government of Western Australia to oversee the development of the Perth AQMP, to monitor implementation of the Plan and to review progress towards achieving its aims. Travel costs are reimbursed in accordance with the Government policy on travel allowance.

The Taxi Customers Advisory Forum, (Forum) invites nominations for the position of Member from Elected Members and Serving Officers. The Council meets 4-6 times per year at the Swan Catchments Council in Bunbury with sitting fees and travel allowance applicable.
