It has carried out numerous brick paving projects for local governments as well as major building companies. Projects undertaken have included footpaths, roads, traffic islands, driveways and shopping centres. Past contracts include paving works for the City of Perth (1981 to 1996), City of Stirling (1997 to 2009) and Town of Victoria Park (1999 to 2009). It has also carried paving works for the City of Nedlands, City of Belmont, City of Wanneroo, Town of Claremont and Town of Mosman Park.</p> | <p>It has been in the brick paving industry for decades and is a current contracted supplier for the City of Joondalup and the City of Subiaco. It provided a clear and concise response to each of the criteria and demonstrated sound understanding of the required tasks.</p> | <p>It is a WA supplier located in Balcatta. It currently employs 25 staff. An organization chart was included. Operational staff comprised of 4 separate paving teams with a supervisor assigned to each team. It has the capacity to undertake works up to 4 separate sites, simultaneously. In addition to the paving teams, it has a specialist bobcat operator to perform all excavation and removal tasks. It is well equipped and resourced and will not be utilizing sub-contractors. It has in place formal OH&S practices and risk management processes and a dedicated senior safety representative.</p> | <p>It operates with a team of experienced key personnel. Each of its 4 supervisors assigned to a paving team has a minimum 6 years paving experience. Its recent and existing local government contracts include similar works for the City of Melville (2005 to 2009), City of Stirling and City of Swan (2004-2010). It has also provided similar works to subdivisions for private property developers since 2003.</p> | <p>It has demonstrated understanding of the required tasks. Should additional staff be required, it has a number of alliances with other brick paving groups and labourers. | It has worked on a number of large paving projects for local governments which included works for the Town of Cambridge, City of Belmont, City of Subiaco and City of Stirling. Examples of major paving projects completed in the past were: Mitchell Freeway Extension, Hodges to Burns Beach Road (8000 sq m); Broadway Nedlands (2800 sq m); Cambridge Street Upgrades, Wembley (9000 sq m) and Rail-Link Joint Venture – Perth to Mandurah Rail-line (4000 sq m).
