## METROPOLITAN LOCAL GOVERNMENT EXTENDED TRADING HOURS PROPOSALS SUBMISSION REQUIREMENTS

Metropolitan Local Governments can apply for extended trading hours in support of special community events.

# WHAT INFORMATION SHOULD BE PROVIDED IN SUBMISSIONS WHEN APPLYING FOR TRADING HOURS VARIATIONS?

Because the application is made by local government, the Department of Commerce will accept the assurance of Council that the relevant qualifying criteria have been satisfied and will only require a brief outline by local governments indicating its reasons for forming this opinion.

When forwarding your submission, please provide the following:

### 1. Sponsoring Authority/Contact details

- · name of sponsoring Local Government
- address
- · contact person
- telephone and fax number

## 2. Dates and/or times variation from the existing trading hours required

### 3. Location

Description of area boundaries or names of individual centres to which the proposed extension will apply.

### 4. Community Significance

Clearly demonstrate that the proposed event has significance and importance to the local community.

### 5. Trader Support

There must be a substantial level of support by large and small retailers.

### Note

The Council must be satisfied that:

- it can be demonstrated that the variation applied for has support from the clear majority of traders who would NOT normally be able to trade during the proposed variation; and
- the attitude of those traders who would normally be able to trade (if applicable) has been considered and is supportive.

### 6. Rights of Traders to Exercise Individual Discretion

Confirmation should be made in the submission that all resident traders have been advised of their rights to exercise individual discretion whether to open or not during periods of the proposed trading extension.

### 7. Organisations, Groups or Associations Consulted

Endorsement or support from relevant trader associations, Chambers of Commerce or other retailer groups is required.

### 8. Views of Local Members of Parliament

The Council must show that it has contacted local Members of Parliament to ascertain their views on the proposed variation and report these.

### 9. Previous Applications

Applications for trading hours exemptions in support of special Local Government sponsored events will be considered no more frequently than twice in any 12 month period. It is also important to note that the Department of Commerce will not consider submissions made within 12 months of a previous application which was defeated / not approved due to insufficient retailer and / or community support. Submissions should indicate the date of any previous application.

## ARE THERE ANY OTHER ITEMS WHICH WILL BE CONSIDERED WHEN DECIDING ON A REQUEST FOR EXTENDED TRADING?

When finalising applications of this type, the Department of Commerce will consider:

### a Proximity of other exemptions

Exemptions for special events are provided to help Local Government sponsored community events achieve their full potential. In this context consideration will be given to the proximity of applicant localities to other localities which have prior exemption approval.

### b Allocation of exemptions.

Submissions will be processed in the order received by the Department.

### **COMMUNITY SIGNIFICANCE**

Each Centre within the Westfield Group aligns itself with a local charity, and since August 2010, Westfield Carousel, Innaloo and Whitford City are proud to partner with Telethon. In this time, Westfield Whitford City alone has raised over \$31,700 for Telethon.
