Following receipt of a proposal, a report will be prepared for Council's consideration which will incorporate all community feedback received to date and will also deal with this petition.</p> <p><u>Update as at June 2012</u></p> <p>At this time there are no plans to develop a Community Garden in Regents Park or Charing Cross Park, Joondalup. Receipt of this petition will be noted in a further report relating to Community Gardens which is anticipated to be presented to Council in September 2012.</p> <p><u>Update as at February 2012</u></p> <p>A report on community gardens was presented to Council at its meeting held on 21 February 2012 (CJ007-02/12 refers).</p> <p>Receipt of this petition will be noted as part of any future report presented to Council in relation to the potential establishment of a Community Garden within the City.</p>
