LOCAL GOVERNMENT ACT 1995

SECTION 3.25

To: Mr Andrew James Hunter 5 Periwinkle Road Mullaloo WA 6027

WHEREAS

- A You are the owner of the land described in Item 1 of the Schedule ("the Land").
- B The Land is within the district of the City of Joondalup.
- C The local government of the City of Joondalup considers the Land to be untidy by reason of the presence of the rubbish and disused material specified in Item 2 of the Schedule ("Disused Material").

TAKE NOTICE THEREFORE that:

- 1 Pursuant to Section 3.25(1)(a) and item 5A of Schedule 3.1 Division 1 of the Local Government Act 1995 you are required to remove the Materials within 28 days of being given this Notice to remove the Materials from the Land.
- 2 Under Part 9, Division 1 of the Act you have a right to object to the decision to issue this Notice by lodging an objection with the City within 28 days of the date of this Notice. You may also apply to the State Administrative Tribunal (the SAT) for a review of the decision to give this Notice if you do not lodge an objection with the City or you have lodged an objection but at the expiration of 35 days after it was lodged you have not been given notice in writing of how it has been decided to dispose of the objection. In addition, if you have lodged an objection and have been given notice of how it has been disposed of, you may apply to the SAT for a review of the decision on the objection within 42 days after the right to make it arose see section 9.7 of the Act.

If you fail to comply with this Notice on or before the day specified very will be ative Prosperous committing an offence under Section 3.25(6) of the Local Government Act 1995. The penalty for this offence is a maximum of \$5,000, together with a daily penalty of up to \$500 for each day on which the offence continues.

Under Section 3.26 of the Local Government Act 1995, if you fail to comply with this Notice the City of Joondalup may do anything that it considers necessary to achieve, so far as is practicable, the

purpose for which this Notice was issued and recover the cost of doing so from you.
