Launched at the UN Climate Summit in New York last September, the Compact is a global coalition of mayors and city officials pledging to reduce local greenhouse gas emissions, enhance resilience to climate change, and track their progress transparently. The Compact demonstrates that regardless of national targets, policies or programs, local action is the most effective response to community concerns about climate change. Benefits for your city are to show your local commitment and leadership, to demonstrate to your community how local efforts can contribute to capping global warming, and potentially to attract investors for your transformative projects and initiatives.

Joining the Compact requires you to complete a greenhouse gas inventory and action plan, and a climate vulnerability study and action plan, within 3 years. Most Australian councils are already well progressed in this area and could easily undertake the Compact requirements. If you join the Compact by 30 September your city will be featured at the Paris COP21. www.compactofmayors.org

## **Transformative Actions Program TAP**

The TAP provides cities with an opportunity to present your most ambitious plans for transforming your city to an international audience at the Paris COP21. TAP will collect and present "ambitious, cross-cutting, multi-sectoral, inclusive and innovative" greenhouse mitigation or climate adaptation actions led by local governments.

Every year during the COP meetings, a range of well-defined, ready-to-accelerate transformative actions will be brought to the attention of international climate negotiations and implementation partners. It is proposed to present up to 100 selected projects to the Paris COP in December 2015.
