Trident Plastics (SA) Pty Ltd (Conforming Offer)	Yes	Trident Plastics has been in business since the 1990's as one of the largest plastics custom moulding companies. It currently employs over 100 employees working three shifts per day, seven days per week. It maintains a quality management and environmental management system which complies with ISO 9001:2008 and ISO 14001:2015 respectively. It provided its safety statistics and safety and risk management handbook. A company structure indicating key personnel who are available during and outside business hours was included. An extensive list of specialised equipment, particularly a plastic injection moulding kit for mobile garbage bin manufacture was documented. Trident Plastics can meet the delivery timeline and dates outlined in the RFT.	It demonstrated considerable experience providing similar services. It manufactures and supplies MGBs to Suez and Cleanaway. It has undertaken major bin roll outs for the Cities of Hobart (13,500 MGBs), Melville (manufacture and delivery of MGBs to over 7,000 ratepayers), Rockingham (90,000 waste MGB and 4500 lid changeovers) and Canterbury Bankstown (manufacture, delivery and roll out of 52,000 waste MGBs). It also supplies MGBs to the City through GC Sales. Date and referee contacts for these and other contracts were provided.	It demonstrated a good understanding of required tasks. It understands the requirements for spares being compatible with the City's bins, delivery to specified locations including to SUEZ, planning of manufacture and delivery timeline for both separable portions, and bin specifications for quality, standards, labelling and hot stamping. It has the capability of recycling waste bins and parts and incorporating up to 30% recycled products into new bins. It also provided examples of bin supply programs and a bin manufacture and delivery master plan timeline. GC Sales WA	Yes	It has been warehousing and distributing MGBs in Western Australia since 1983. The bins offered will be manufactured by Trident Plastics (SA) Pty Ltd in South Australia and delivered within four weeks in accordance with the City's timeframes and locations for both separable portions. The company has one key member of staff with over 30 years' experience in the distribution of MGBs and contactable anytime. The company is equipped with a truck, utility vehicle and forklift with support from a sub-contractor for delivery. It indicated a 100% clean record and attached its safe work method statement. A safety management policy was not supplied.	GC Sales WA demonstrated its sound experience in the top-up and roll-out supply and delivery of mobile garbage bins. It currently holds two on-going supply contracts and manages both in conjunction with Trident Plastics for the City of Rockingham (2017 – 2020) and the City of Joondalup (2015 – 2018). It also successfully managed the City of Rockingham bin roll out in 2017 to approximately 50,000 residential properties. GC Sales WA provided a list of referee contacts.	GC Sales WA has demonstrated a sound understanding of the required tasks and logistical requirements for the supply and distribution of MGBs for both separable portions. Its delivery timeframe for on-going top-up of MGBs is within four (4) weeks from date of order including wheels and smaller components. Delivery for the three-bin project is acknowledged to be in accordance with City's requirements. It confirmed it will supply the MGBs to the specification and warranty requirements as outlined in the RFT. Mastec Australia Pty Ltd (Conforming Offer)	Partially	Mastec Australia is a privately-owned company that launched MGB manufacturing in 2002. It recently completed building a new warehouse facility employing over 40 full time staff. A business structure indicating the support team was provided, however skills, experience of key personnel or emergency contacts were not addressed. Details of specialised equipment indicate it utilises the bin injection moulding method which is the latest bin manufacturing technology. A safety policy and list of various safety work methods were provided; however, safety statistics were not evident. It stated it would pre-book and utilise 40-foot containers for the supply and loading of MGBs for both separable portions. It indicated it would manufacture to schedule in order to meet City requirements.	Mastec Australia demonstrated extensive experience completing MGB supply and roll-out services for multiple local governments in Australia. Examples include manufacture, deliver to depot, assembly, distribution and collection of retired bins for Barossa Regional Council (SA), Dubbo Regional Council (NSW) and Wagga Wagga (NSW). In Western Australia it completed the three-bin roll for the City of Stirling with over 130,000 bins delivered in 2015. Referee contacts were provided.	It demonstrated some understanding of required tasks. It acknowledged the City's requirements for both separable portions and provided its approach for order preparation, quantities, manufacture and loading, delivery to depot, recycling, and bin quality and branding to relevant standards. Concern was raised regarding its delivery schedule which is driven by MGB manufacture rather than the City's schedule. A timeline for each bin size was provided. It does not manufacture lid pins to suit bins the City has in its possession. This means lid pins provided by Mastec would not be suitable for current lid change over requirements.	The company is based in Adelaide and also has services in Western Australia which comprise of an office and warehouse in Jandakot. Mastec Australia have a full time Sales Representative who lives in the City.	58.0%	Separable Portion 1 \$670,176	3
Not all requirements have been met. Small deliveries from its Jandakot warehouse will have added freight costs. Its timeline is not in accordance with City's timeline. Not all requirements have been met. The Offer proposed a bin body that is black in colour. This does not conform to the City's requirement for green bodied bins.
