# OVERVIEW

The community was invited to provide feedback from 22 November 2018 to 19 December 2018 on a proposal to install a toilet facility at Shepherds Bush Park in Kingsley. The City collected a total of 302 valid responses throughout the 28-day advertised engagement period. Of the 321 residents and landowners within a 350 metres radius of Shepherds Bush Park, 43 submitted feedback. Further, 13 Community Engagement Network members submitted feedback, as well as 247 community members who were not directly engaged.

The majority of respondents (273) reside in the City of Joondalup, with over two-thirds of these coming from the suburb of Kingsley. The remaining 29 respondents reside in suburbs outside of the City, with the majority of these coming from the Cities of Wanneroo and Stirling.

Respondents were asked to indicate whether they support or oppose the proposal to install a toilet facility at Shepherds Bush Park, Kingsley. 90.1% of respondents indicated that they “support” or “strongly support” the proposal.

Comments on the proposal highlighted that having a toilet within the park would increase accessibility to park users and allow for longer visits, whilst also reducing the incidence of toileting in the bushland. Other respondents expressed concern about the negative impacts a new toilet facility may have on the residents living in houses adjacent to the park, and that such a facility could lead to a rise in antisocial behaviour, such as vandalism, drug use and loitering.

# STAKEHOLDERS

Additional stakeholders, including park visitors, and interested residents and landowners living further than 350 metres from the park, were also *indirectly* engaged by the City via the engagement materials described below.

Local residents and landowners within a 350 metres radius of Shepherds Bush Park were sent information packs through the post containing a cover letter and a Frequently Asked Questions document. These stakeholders were invited to submit feedback through the online Comment Form available via the City’s website. These stakeholders were also advised that hard-copy Comment Forms were available on request.



## Cover letter to residents and landowners within a 350 metres radius of Shepherds Bush Park and cover letter to government stakeholders (see Appendix 1–2 for full):








## RESPONSE RATE

The City collected a total of 302 valid responses throughout the 28-day advertised engagement period. Responses that were considered valid include all those which contained contact details enabling identification, and were submitted within the advertised engagement period. Where multiple Comment Forms were received from the same respondent, these were combined into one response.

Of the 302 respondents, 300 completed the Comment Form online and an additional 2 respondents provided written feedback via email. Of the 321 residents and landowners within a 350 metres radius of Shepherds Bush Park, 43 submitted feedback. Feedback was also received from 13 Community Engagement Network members residing in Kingsley, indicating an overall response rate of 13.1%. A further 247 community members, not directly engaged, also provided feedback.


# DEMOGRAPHICS

### Responses received by suburb:




## Respondent membership/affiliation to community groups

# COMMENT FORM QUESTIONS


QUESTION: “The City is proposing to install a toilet facility at Shepherds Bush Park, Kingsley. Please indicate whether you support or oppose this proposal.”

Respondents were asked to indicate whether they support or oppose the proposal to install a toilet facility at Shepherds Bush Park, Kingsley on a 5-point scale from “strongly oppose” to “strongly support”. The majority of respondents (272) indicated that they “support” or “strongly support” the proposal; 19 respondents indicated that they “oppose” or “strongly oppose” it.

Further analysis was conducted to compare the level of support indicated by local residents and landowners within a 350 metres radius of Shepherds Bush Park with the level of support indicated by all other community members. Respondents who do not reside within 350 metres of Shepherds Bush Park indicated stronger support, with 95.0% indicating that they either “support” (22) or “strongly support” (224) the proposal. Just over one-quarter of respondents living within 350 metres radius of Shepherds Bush Park indicated that they either “oppose” (3) or strongly oppose” (8) the proposal, while only 6.6% of other community members indicated that they “oppose” (5) or “strongly oppose” (8) the proposal. 

**QUESTION: “Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley?”**

Respondents were asked if they had any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley. A total of 213 respondents provided comments. A significant number of comments (72) were supportive of the proposal due the fact that Shepherds Bush Park attracts a high volume of visitors, most of whom are children. More than 20% of respondents who provided a comment highlighted that having a toilet within the park would increase accessibility to park users and allow for longer visits, whilst also reducing the incidence of toileting in the bushes.

A number of respondents commented about the negative impacts a new toilet facility may have on the residents living in houses adjacent to the park, and that such a facility could lead to a rise in antisocial behaviour and crime, such as vandalism, drug use and loitering. These comments have been broadly grouped and quantified in the table below. Verbatim comments have been randomised and are provided at Appendix 19.

## Shepherds Bush Park, Kingsley — Proposed Toilet Facility Frequently Asked Questions

### **What is the purpose of the community engagement?**

To seek community feedback on a proposal to install a toilet facility at Shepherds Bush Park in Kingsley.

### **Where is Shepherds Bush Park located?**

Shepherds Bush Park, Kingsley is located along Barridale Drive and is adjacent to the Robertson Road Cycleway and Shepherds Bush Reserve.

### **Why is the City proposing to install a toilet facility in Shepherds Bush Park?**

The City has recently installed a number of unique assets within Shepherds Bush Park, including a bike skills track, play space, picnic equipment and a pump and jump trail. These facilities have proven highly popular with the community with increasing long-stay uses being experienced for picnicking and recreational activities.

As a result, the City continues to receive requests for an ablution option within the park, and is now seeking feedback from the community on the potential installation of a small toilet facility.

### **What type of facility is being proposed?**

The City is proposing a low cost, low maintenance facility with the following features:

- Universal access toilet
- Septic tank
- Connecting path network
- Lighting

The proposed (approximate) location for the facility is shown in the map overleaf.

### **When would the works be carried out?**

The timing of any potential works is yet to be determined, as the City is seeking feedback from the community before progressing the proposal.

If supported, the works would be considered as part of the annual capital works planning and budget process to determine an appropriate schedule for the project across the City's forward works plan.

### **How would the opening and closing of the toilets be managed?**

In line with similar toilet facilities across the City, the toilets would be operated by a time lock system, which would automatically open at 6.00am and lock at 8.00pm.

### **Would any trees be removed as part of the proposed works?**

Should the proposal be progressed, the City does not intend to remove any existing trees. However, if any trees are identified as being in poor structural condition, or dead and presenting a hazard, they would be removed and replaced with new trees in appropriate locations. Pruning of trees that overhang pathways or infrastructure would be carried out as required.

### **How would the proposed works be funded?**

The facility is estimated to cost between \$80,000 and \$120,000. This will be dependent on the final design option pursued, should the proposal be progressed.

**Who is being engaged on this proposal?**

The City is directly engaging with the following community stakeholders:

- All City of Joondalup landowners and residents within a 350 metre radius of Shepherds Bush Park;
- Community Engagement Network members living in Kingsley;
- Friends of Shepherds Bush;
- Kingsley and Greenwood Residents Association; and
- Local, State and Federal parliamentarians.

In addition, signage has been erected in Shepherds Bush Park and all information is available on the City’s website. Anyone interested in the proposal can complete a Comment Form. Responses are limited to one per person.

**How do I provide feedback on the proposal?**



# Toilet plan for bush park

THE City of Joondalup is investigating the possibility of installing a toilet facility at Shepherds Bush Park in Kingsley.

The park has become a popular community facility, with a bike skills track, pump and jump trail, play space and picnic equipment.

At the September council meeting, Cr John Logan requested a report on the feasibility of installing a toilet facility at the park, which was presented to the council at the November 20 meeting.

He said the park attract-



ed “large numbers of people” and the nearest public toilet was about 700m away at Barridale Park.

He also said when compared to Delamere Park in Currambine, which was of a similar classification and size and had a toilet, Shep-

herds Bush Park had three to four times more visitors.

Though councillors unanimously voted to consult the public on the possibility of installing a toilet facility, Cr Tom McLean said there were no budgeted funds for the project.

The council report said the cost of installing a “modest” toilet facility was estimated between \$80,000 and \$120,000.

At the September council meeting, Cr John Logan requested a report on the feasibility of installing a low cost, low maintenance toilet facility at the park, which was presented to the council at Tuesday's meeting.

He said the park attracted "large numbers of people for significant periods of time" and the nearest public toilet was about 700m away at at Barridale Park.

He also said when compared to Delamere Park in Currabmine, which is of a similar classification and size and has a toilet, Shepherds Bush Park had three to four times more visitors.

Though councillors unanimously voted to consult the public on the possibility of installing a toilet facility, Cr Tom McLean pointed out there were no budgeted funds for the project.

"The consultation and engagement process will probably be completed by the time we get to the budget round so then it will be up to my colleagues to justify the expenditure," he said.

The council report stated that costs associated with installing a "modest" toilet facility at Shepherds Bush Park was estimated between \$80,000 and \$120,000.

The City is seeking feedback to determine the level of support for the installation with community consultation starting today.

"I encourage all members of the community who enjoy the wonderful assets on offer at Shepherds Bush Park to have their say on whether the proposed toilet facility should proceed so the council can make an informed decision," Mayor Albert Jacob said.

"The proposed location and design of the toilet facility has been selected to ensure minimal impact on park users, the neighbouring bushland area and residents living nearby."

Submissions can be made before December 19 at [www.joondalup.wa.gov.au](http://www.joondalup.wa.gov.au) or by calling 9400 4255 for a hard copy.

The City will also directly consult with residents within 350m of the park, the Friends of Shepherds Bush group and the Kingsley and Greenwood Residents Association.

QUESTION: “Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley?”

Where multiple Comment Forms were received from the same respondent, these were combined into one response and identified by [multiple submissions]. Minor alterations have been to spelling/grammar to enhance readability.

<b>Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)</b>
<i>Definitely a good idea.</i>
<i>We always love spending time at this park, but our trips are always cut short due to one of our children needing the toilet.</i>
<i>I work near the park and my child goes to a local school, so I have taken my child to the park after school several times; however, our use of the park has been cut short because there are no toilet facilities. We have also had to overlook the park as a venue, despite the great playground and bike track, for meet ups with friends, as only short visits are viable because children seem to have a tendency to need the toilet more often than teenagers or adults.</i>
<i>My children head here most days on their own and having toilets brings a level of concern regarding safety. Please use the money to build a mini skate park instead.</i>
<i>1. Security — a. Security cameras outside the toilet to discourage unfavourable activity nearby. b. Is there a possibility of undesirable persons loitering around the area? c. What external lighting will be in place? 2. Cleanliness — a. How often are they cleaned and by whom?</i>
<i>It's always busy, our house is too far away to pop back for a toilet break.</i>
<i>Of course you need toilet facilities if you're wanting people to stay and use the BBQ facilities. It's difficult enough when you take your children to enjoy the park and BMX track then need a toilet.</i>
<i>This is a great idea, as long as it is a secure, self-cleaning facility.</i>
<i>This would be a huge asset to the park. It is the main downfall of the park not having toilets. It is very hard for kids to hold for any long period and it either means going home or having to do a wee on a tree.</i>
<i>Our day-care centre uses Shepherds Bush Park for excursions; having a toilet facility would make our experiences at the park far more pleasant and allow us to stay for a longer duration of time.</i>
<i>Why would you locate it there? Many houses that it will affect. Why not have it the other end of the BMX track where it will have little effect on residents? It is asking for trouble in that location; lots of places to hide out-of-site. I will have the police on speed dial for sure, and when they get sick of turning up, will it be up to us to clean up the mess?</i>
<i>[multiple submissions] The toilet needs to be inspected by the ranger more regularly (nightly) in the evenings as anti-social behaviour has been occurring after dark. They also need to be located toilets as far away from all houses as possible and be locked after dark.</i>
<i>With young children it is a must to have a toilet.</i>
<i>Slight concern that it might attract anti-social behaviour.</i>
<i>Urgently needed. There are BBQs but no toilet. Crazy!</i>
<i>I have wanted one there since it opened, but I do worry about druggies using it at night and leaving needles around, because even high school kids have been known to do drugs in the park before school as well. Is it possible for them to be locked at night to deter drug users please? And will they be cleaned as regularly as the ones at the other park on Barridale — have been disgusting lately too, there was a sink full of vomit — it wasn't nice.</i>
<i>It is very much needed, especially for the little ones. If it is built, please make sure it's built to blend in with the environment and surrounding features.</i>
<i>I regularly attend this park with my young children and, almost every time I go, I see a child using the bush nearby to go to the toilet, toilets on site would be a great addition to the grounds.</i>

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*My kids and I frequently use the track and love to have picnics with friends there; a toilet facility would be great.*

*It is an absolute necessity as the majority of users are small children and parents. Most of whom are pregnant or had babies, both at risk of struggling to hold in a wee!*

*Wonderful idea — the park is a great family place but having picnics there is troublesome with young children who need the toilet. We fully support the installation of toilets.*

*It's a definite yes! Totally needed.*

*I am thrilled to hear that this could be happening. Love the new parks being built everywhere but they must have toilets. The parks are for children, and children need toilets. I do think they should be locked at night, but understand that is a thing that can cost the City extra which it may not have.*

*Thanks for writing to us on this issue. We are not at all surprised at this proposal, as the City should well have known that the creation of the attractions at the Park would cause users to demand a toilet facility. It is obvious that the City should have master-planned the area and not developed it in on a piecemeal basis. Had the City presented a master plan for the site, it is likely that the local residents would not have supported it and seen it stopped. Given that the users seem to have coped and survived quite well for the last year without a toilet, one wonders why this could not continue. You also need to realise that the majority of users of the facility are not local residents and many are from outside the City. It should also be noted that the previous Mayor made it quite clear that the City would not be establishing a toilet at the Kingsley park. The City needs to realise that the toilet facility may well increase usage at the park and thereby add to the impacts already apparent to local residents. Should the City decide to proceed, may I suggest that the closing time be adjusted and aligned to sunset and not remain open after dark. This would require seasonal adjustment. Also, I would expect that the City will conduct a review with local residents within 18 months of establishment to establish acceptance or otherwise. The City would also be wise to review cost-benefit, according to maintenance costs/vandalism and confirm justification for the facility.*

*It is very much needed given the high volume of community members using use of the park!!!*

*My request is that it is similar to the toilets in Scenic Reserve Park.*

*This playground is aimed at children of a range of ages, including toddler and preschool age children, and it is essential that toilet facilities be provided for this cohort in particular. Removing all your children and their bikes from the park when one needs to go (and at that age there's no holding on) and strapping them into the car or walking 700 m (as the sign says) to the nearest toilet, is completely impractical. The park attracts a range of people and is also a good facility for teenage children, who should also have access to toilet facilities. The proposal is long overdue.*

*We live in the area, it used to be quiet, it is no longer, we get constant noise on the weekends, we have more and more antisocial behaviour, we have people from out of area driving and parking in our street and staying for long periods of time, and this is without a toilet. There is a toilet block 700 metres down the road at Barridale oval, a park of this size does not require a toilet. What are the noise regulations? And I feel there needs to be a re-vegetation program to the west of the park to try and minimise the noise impact which has affected us since the installation of the pump and jump. Since we feel our comments and concerns will be completely disregarded as the toilet will most likely go ahead anyway. What security measures and patrols are the city of Joondalup going to undertake? Due to this toilet installation we strongly suggest it not be open after 6 pm, and also strongly oppose any future external lighting of the park which would then attract visitors for longer periods of time, thus further impacting our previously quiet location.*

*A toilet facility would be a fabulous addition to the already gorgeous park at Shepherds Bush. A convenient toilet is often the deciding factor when choosing a park to visit with small children.*

*It is a good idea, but needs to be closed in the evening and opened up the following morning to alleviate unwanted behaviour or vandalism*

*We go to this park all the time and it needs toilets. My son is happy to use the closest tree, but I'd much rather there was a toilet for me!*

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*I think it is desperately needed, the park is very popular and people don't walk the 700 odd meters to Baradale to use the facilities they just use a tree.*

*I and my children use the park regularly we would use the park more often for catch up with friends if it had toilets. It is an extreme inconvenience to have to drive down Barridale to use the toilets there.*

*Consideration should be given to the homes closest to the facility. The toilet block should be positioned away from these homes. It should be locked overnight to prevent the local nuisances from turning it into a drinking hole. These homes were built in good faith in a quiet area that is now fast becoming a noisy playground.*

*I think we need this, as the amount of children attending this area, and if need the toilet, you have to leave. Not sure what is intended to be built, but one like they have in Allenbrook water play area would be fantastic. I think they are a safe option.*

*Needs to be child friendly, clean and safe.*

*In order to stop people [- - -] in the bushes or behind trees (as have been personally observed), I believe toilets should be installed. If you've installed a play area that has attracted a large attention of people, you should have accounted for that!*

*I welcome the toilet facility being provided. However, the proposed location is not ideal. Not on, near the only shaded grassed area in which people sit, relax and enjoy the surroundings. I feel it would be better placed, possibly closer to the road, towards the northern side of the park...*

*This park definitely needs a toilet facility. Families with young children frequent this park and access to toilets are essential with children, especially young children. Last time I frequented this park with my [- - -] year old, I had to drive to my house in Woodvale as he desperately needed the toilet and needed a change of clothes as there is no toilet there!!*

*Please also consider quality baby change facilities also, given that the park now caters for younger children, especially with siblings!*

*My main concern is that it may interfere with the natural look of the area. Also worried about upkeep of both the toilet and the existing facilities given it may attract many more people from outside the area if toilets are put in. Can the car park keep up? The track has also had to be closed for significant repairs once already. That said, it is a great park and we are thankful for having it. The toilets themselves would be useful if the problems above are managed well.*

*The park has become very busy with family gatherings, including small children who can't hold on long enough to get home or to Barridale Park. A toilet will also stop youngsters defecating in the bush. The site is now busy enough to easily justify a toilet.*

*Would prefer a wash-down toilet like those used in City of Perth or Subiaco. Initial costings are higher, but maintenance costs will be much lower.*

*It'll stop people weeing in the bushes!*

*As the park is highly visited by young families, toilet block would be much appreciated instead of rushing to Barridale Park or worse. Thank you!*

*I visit this park very often with my 2 boys, but it is sad there is no toilet. People are often seeing using the bush for a wee. Toilet are needed there.*

*We live [- - -], we are sometimes affected by people gathering after dark, so it would depend where the toilets are located and if they self-lock after a certain time. There are toilets 700 m at the other park, so I am not sure they are necessary, but if they are, the best area would be in the grass dip to the right of the bike park; this way, there would be toilet facilities, but not in view of houses opposite.*

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

To the Joondalup Council

I, along with my family, are long-term residents of Kingsley over a period of some [ - - ] years. I am a member of the [ - - ] which has given me the opportunity become familiar and appreciate this special Bushland Reserve.

From the outset, I was not in favour of the development of the 'Bump and Jump' bicycle tracks that the Council has completed, as I felt and still feel it to be, an inappropriate development in the precinct of such a sensitive biologically unique bushland. The existing old growth Tuart Trees have been put at risk by the build-up of soil, rock and surface treatment associated with the development of these bicycle jump tracks.

The reasons that I object to the Proposed Toilet Facility are as follows:

1) The Proposed Toilet Facility will result in the destruction of many old growth trees and have a negative impact on the area of bushland canopy cover which already is under extreme duress due to large scale die-back within the Bushland Reserve. Even if the Council proposes to mitigate the effect of this clearing of bushland for the Proposed Toilet Facility by planting replacement trees, this would not be acceptable, given that replacement trees would take many years and generations to grow to maturity (which is not guaranteed) given the harsh effects of Climate Change.

2) The Proposed Toilet Facility will enlarge the overall development associated with the Bump and Jump Bicycle Tracks which will entice a larger number of visitors to the area and result in the Council being required to enlarge the existing vehicle parking area. This already is often used to a maximum at weekends and holidays. By not enlarging further the development of this area, people will come to understand that this is only a small community facility, not an enlarged amusement park.

3) The Proposed Toilet Facility may encourage possible deviant behaviour which, given the proposed location, will be hard to police and may therefore endanger public safety.

4) The Proposed Toilet Facility will incur ongoing costs to the Council associated with the cleaning and maintenance of this facility.

In closing, I request that the Proposed Toilet Facility be rejected and that the Council keep the area as currently maintained.

I think it would be a great addition, with young kids, we always have to leave because someone needs to go to the toilet.

It is a must, given the number of kids, in particular young children, who use the park, especially when trying to toilet train kids.

Yes please! We have [ - - ] kids under [ - - ] and lack of toilets stops us from using the area as much as we would like.

It must be secure, sanitary and safe and lockable after 6 pm. A facility similar to those in Europe and seen in Northbridge would be ideal.

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*This park is well frequented by parents with young children on every day of the week. It is very popular with young mums with pre-schoolers and during the school holidays. It is frequented by people from neighbouring suburbs, as well as locals. I have had to take my young grandchildren into the bush on a number of occasions because they are too young to be able to 'hold on' whilst I drive them home to Woodvale or to the Barridale toilets.*

*I think this would be excellent and much safer than having to walk to the other toilets. Baby change facilities would also be good.*

*I think this is a fantastic proposal. This park would benefit greatly from these facilities.*

*Currently there are no toilet facilities at this park. Considering the high use of this area by family groups, it is important for a toilet facility to be built.*

*Strongly support due to heavy patronage of the park and lack of toilet facilities within practical distance, likely leading to public urination.*

*As a regular visitor to the park with my small children, we love the bike track, but it is difficult to manage without toilets.*

*My young family love this park, but not having a toilet at the park makes it difficult to bring children to.*

*A great idea. Since the bike park was added to the playground, the visiting population has grown. We had to leave the park early on several occasions due to no toilet in the park area. I'm happy to see there is an initiative for one.*

*It is so lovely to see so many families enjoy this facility. My grandchildren love to play there when they come to visit. I see many children's birthday parties held there and know a toilet facility would be most welcomed for those people attending. It's a long walk/drive to Barridale Park for a small child who needs to go to the toilet. I would hope they are locked after hours to avoid any unsavoury behaviour.*

*We often spend hours at Shepherds Bush Park and it would be fantastic if there were toilets, which is often the reason we have to leave.*

*As a local resident, I do not believe that the location of the proposed toilet facility is correct. It will be [ - - ], [ - - ]. There is plenty of land to the right of the bike track, down a dip where the facility will be out of sight to all residents. I am particularly concerned that the facility will be open until 8 pm, why is this necessary when it will be dark by this time for most of the year? Anti-social behaviour will be encouraged after dark, causing a nuisance to local residents. The park is for children, they will not be at the playground after dark and therefore the facility should be locked no later than 7 pm. The park is already a very popular venue. people at the moment will spend a few hours there before leaving, perhaps due to no toilet. The park is in the middle of a local residential area, it shouldn't be a venue where crowds are drawn to. Installing a toilet facility will enable people to stay longer and cause overcrowding. We already have issues with parking, the new car park does not service the demand and we have cars parking on verges frequently. Overall, I do not agree that the proposed toilet facility is in the correct location, and definitely do not agree that it should be open after dark until 8 pm.*

*Yes! This is not fair to those residents immediately adjacent! The proposed site is way too close to [- - -]. We already have issues of noise and antisocial behaviour of people using that park at night time. Ranger needs to be there more! We already have issues of a squatter between [- - -] (ask the Ranger) and people lighting fire in dead scrub between [- - -]! I understand why people want a toilet there and well done for a great park, but please move toilet to other side of the BMX track [- - -] or not at all! It is so noisy and busy on Barridale already!*

*The conservation area is not in need, but the bike park desperately needs one. Being that it's frequented by children, who are unable to hold their bladders (due to only needing to go when it's completely full, unlike adults). By not having a toilet facility, it is somewhat penalising girls, as they are not able to just wee just anywhere. In addition, when installing the toilet facility, place include additional drinking facilities closer to the main bike track. A survey for improvements should also be circulated, as the park is wonderful for larger kids, however it is a little lacking for the smaller kids, such as shade over the main play equipment, and a barrier around the sand areas that stop toddlers from accidentally riding into the sand (which I've witnessed in several occasions). Thank you for the opportunity to personally submit an opinion.*

*We use this fantastic facility regularly as [- - -] live [- - -], having a toilet available for the little ones to use would be fantastic!!!*

*Desperately needed. Kids going to the toilet in the bushes. Heaps of people every day. Closest toilet Barridale Park. Too far away.*

*I would also support baby change facilities and a large family bathroom.*

*A toilet will be greatly appreciated.*

*Hooray!*

*Great park, my [- - -] year old and [- - -] year old love it! I am [- - -] and think a toilet is necessary.*

*As a [- - -] I think this is an excellent idea. Will stop people "caught short" from going in the bush.*

*The installation of a toilet facility will allow families to spend more time at this wonderful addition to Kingsley. Although I do not use the bike park, I do [- - -] and am amazed to see how many people using this space. From the moment it opened I mentioned how the only thing was missing was a toilet. Please, please please install a toilet here.*

<b>Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)</b>
<i>The families that use the bike park are in need of this toilet facility. Please ensure that it is family friendly, with access for prams etc as most families using the kids bike playground are usually young families with toddlers and babies in prams or pushers. A change table would also be needed.</i>
<i>We would visit more often if there were public toilets.</i>
<i>It should have been provided when the facility was first built. It's well overdue.</i>
<i>It is ridiculous a new facility like this is built with no toilet block. We queried this several times during building only to be told it would never happen as the one down the road is close enough. What toddler can hold on whilst parents pack up and potentially get other kids in the car and make it in time. Not to mention the number of teenagers weeing within the jumps area!!</i>
<i>There are no other toilets nearby.</i>
<i>I myself do not use the playground/bike park, but I [- - -] and see how many people use it and I believe a toilet facility would be advantageous — but it must close early evening (as I believe is proposed).</i>
<i>As a former Kingsley resident of [- - -] years, I personally I can't understand why it was not originally budgeted for. Yes, it is long overdue, as it is not practical to expect parents (many parents who need to take one child to the toilet while their other children have to be packed up as well just to answer one's call of nature).</i>
<i>It would further limit the use of the nature reserve as a public toilet for the children. This should have been first thought in the original redevelopment. Whomever forgot that children can't make it to Barridale Park between needing to go and having to go, hopefully lost their job, as clearly, they don't have children.</i>
<i>As so many people use the track, especially children, it would be a fantastic idea to install toilets.</i>
<i>Very good idea to install a toilet. Some people stay at the track for a long time. My grandson rides until he drops, and he really loves it. It is very popular with a wide range of ages.</i>
<i>All parks, with these types of facilities catered to parents and kids, should have toilets</i>
<i>Appropriate location and style of the toilets is essential, so that they don't increase the impact the park already has on local residents.</i>
<i>I understand that there are associated costs to the City with installing and maintaining a new facility, but as a parent that has gone through toilet training, the decision to attend a park or complex was directly linked to how close the toilets were and we didn't visit anywhere without a toilet. Now it's not so much of a factor, but being a family oriented public place, I think it would only be seen as a benefit.</i>
<i>This facility should be a multi-use toilet facility, the thought I have is. Shenton Park has a multi-use toilet that enables you to push button to enter you have 10 mins once in the facility to use the convenience. The toilet is stainless steel, and the toilet flushes when you use the hand wash facility within the toilet area. The light comes on upon the opening of the door. This would be a one-off facility multi use, instead of a toilet block with male and female separate use.</i>
<i>It's a well-used park which should have a toilet facility.</i>
<i>It is very much needed as many young children attend the park and, not having access to close toilets, limits time spent at the park. The toilets should also be locked overnight to deter people who are up to no good.</i>
<i>[multiple submissions] It is much needed. My young children enjoy this park, but our time can be limited there without this amenity.</i>
<i>It is to me inconceivable there are no toilets here. I often take my grandchildren and we have to either dash to the shops or find a toilet training toddler. I would hate to live adjacent to the park. It must smell ripe in the summer.</i>
<i>This reserve attracts many visitors and it is a large distance to the nearest toilet facilities. Many of the visitors are very young and when they need to relieve themselves they can't wait long so facilities on site would be very convenient.</i>
<i>My family frequently visits the park. I have a [- - -] year old son and a [- - -] month old daughter. Installing a toilet would be very helpful! Please also consider baby changing facilities.</i>
<i>Please lock overnight.</i>

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*I have a [ - - ] year old and a [ - - ] year old who use this park and it would make things 10,000 times easier if there was a toilet there we could all use. Thank you.*

*Most welcome and desperately needed in case of an "emergency" due to number of people and children going to that park.*

*This park is extremely popular, and toilets would make it so much easier. From memory, my [ - - ] year old had to wee on a tree. I've seen someone take a potty out before.*

*This is a fantastic facility for young and old and is great to see in Kingsley. We often see parents with young children either walking or jumping in the car to head to nearest facility at Barridale Park. This is a no brainer.*

*As long as it doesn't involve any part of the Reserve, I am fine with agreeing to this proposal.*

*I would absolutely love one as the kids love going here but it does make it less appealing now we're toilet training. I am, however, concerned it will create unsocial behaviour at night with alcohol and drugs. It would be great if it could somehow be locked at night or monitored? I'd hate for my kids to find something disturbing in there. The toilets at Rainbow Waters in Ellenbrook are great — they seem hygienic and safe.*

*Not sure why it has not been done earlier. Desperately needed at a park that encourages young children to visit as well as providing BBQ facilities.*

*Not necessary as there are toilets at Barridale Park just down the road.*

*We live [ - - ] and we do not want drug or rape problems here. There is a toilet in the park near there. Why don't they use it? I have [ - - ] kids and they go toilet before going there and never have problems.*

*I think it's essential that toilets are installed at all playgrounds, as children cannot "hold it in". Ideally it will be placed away from local houses and be locked securely at night. We would use this park more often if it had toilets.*

*Just to be as discreet as possible and to be a decent facility while discouraging anti-social behaviour.*

*I would strongly support this proposal given the number of small children who are toilet training that frequent the park and would be unable to 'hold on' for a very long dash 700 m to Barridale Park or home when the urge hits. I have seen many desperate parents ferry their children into Shepherd's Bush to use as a toilet, which is not ideal.*

*All parks should have toilets close-by.*

*About time.*

*Badly needed but sorry for people who live close by. Hopefully it won't encourage hooligans at night.*

*Adding these facilities will make this great park even more accessible to all people, especially families.*

*My toddler loves this park but difficult for toilets so far away with a baby in tow too.*

*Needs to be installed to support the facilities and the age group that use those facilities.*

*Please also include baby change facilities.*

*Please install a toilet, it difficult with toilet training toddlers not to have one.*

*Hi, I would be happy to support the new toilet facility; however, only if the toilet would be scheduled to close at 6 pm later — 8 pm is just too late. I feel this facility is mainly for young families with young children and understand the need, as it's so busy. Most families would have left the park by 6 pm. (I presume, on the odd occasion that a party was planned, that could be arranged for a special late time allocation through yourselves if booked correctly). This 6 pm close time will deter unfavourable transactions taking place at night, and deter teenagers from hanging around after hours, which is my main concern. I would also like the amenities to be serviced (bins) regularly please. Thank you for reading my concerns, I am sure that they are the two main issues that many would have. kind regards [ - - ].*

*The proposed toilet block at Shepherds Bush Park will be a great addition to what is already a good park. The park is frequently used by young families, having a toilet on site solves many problems that parents of young children face.*

*This will be a much-needed enhancement to what is otherwise an excellent facility for young people and families. I assume that, for security purposes, the toilets will be closed at night.*

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*Definitely necessary when you have small kids and nearest toilet is a long distance away.*

*Very badly needed, especially for those with young children, and especially if you don't drive to the park.*

*This is a great facility that would be even better with toilets. Especially as it is frequently used by families.*

*If this is the extent of previous consultation, I have little faith in any consultation that takes place now. I understand that you have previously indicated that there was no requirement for local consultation as the pump and jump trail was merely an upgrade. However, it is clear from the development of the site, which now includes parking, BBQs and a proposed toilet, that the extent of the project is much wider than indicated in the Lottery West Grant application. Is this current process again token consultation, with little regard for the residents who are directly affected?*

*We built our house [ - - - ], along with other local residents in [ - - - ] close to pristine bushland, which is supposedly protected. Our family should not be criticised by visitors from all over Perth, via the [ - - - ], for feeling distressed about now having to live [ - - - ] to a busy playground, bike track and pump and jump track, a BBQ area that is booked out by you for parties, with increased traffic, noise and parking problems, and where drug deals take place. You now want to install a toilet without any regard for our concerns and those of our local neighbours. We cannot understand why this facility was not placed at Barridale Park, where all the public facilities, such as parking and toilets already exist. It would have comfortably fitted on that park and I urge you to reconsider any further extensions to this project in Shepherd's Bush.*

*It was good to talk to you today.*

*Further to our conversation, here are a few points I would like the City of Joondalup to consider please:*

- 1. The original application for Lotteries West funding by the City of Joondalup (COJ), (obtained through Freedom of Information) indicated that the COJ has rated the area as of High Risk for predatory behaviour.*
- 2. Given this, the location of the proposed toilets is too secluded to be safely monitored from the road by police, rangers and parents.*
- 3. I suggest that if the COJ is going to place toilets on this site, then they should be closer to the road, and further north of the bike track.*
- 4. This would be safer for the children.*
- 5. Given that people are likely to stay longer if COJ installs toilets, the turnover of parking places will be reduced, and we will likely have another parking overflow problem. The earlier identified dangers of parking at Rosella Court, with the children crossing the bike track near the bridge, will again be an issue.*
- 6. I suggest, that if COJ is going to install toilets, then the sandy patch north of the existing car park area should be developed into parking.*
- 7. Given that planning on this project has been mainly back-planned, I suggest, that if COJ is going to go ahead with the toilets, that this time, COJ completes a risk assessment, and plans ahead for issues, to ensure the safety of the children, before anyone is hurt.*
- 8. I am concerned that the voices of the key stakeholders, who live [ - - - ], will be drowned out by the sheer volume of visitors to the bike track, who do not have to live next to a toilet. Consultation that is based on numbers does not take this into account. The quality of conservation is also a concern. Previous consultation submitted in the Lotteries West grant application indicated that COJ consulted with a 14 year old, a 15 year old, a grandfather and two BMX clubs. The lack of transparency in COJ consultation to date is of serious concern.*
- 9. Finally, the disregard COJ has shown for the status of this conservation site as Bush Forever is hard to understand.*

*I appreciate you following up for me [ - - - ], and wish you and your family a safe and happy Christmas.*

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*It would need regular monitoring, so it gets used for the purpose of it, rather than for negative use, especially as so many young children and their families attend this park. I wouldn't want my children to go to the toilet and view something, such as a needle or other things. Perhaps keep it locked at night or from early evening and open in the morning. But so many times I have been there with friends and the children require the toilet, I have only just very recently [- - -], but before that was living in [- - -] so always had to leave early to take a child to the toilet. So, this would be great for visiting families too!*

*If no amenities are provided and kids need to go, they will go in the bushes, which is not ideal.*

*It's a wonderful park, evident by the large numbers that use it. This a toilet is essential.*

*The park has many long-stay elements encouraging users to enjoy the space. I understand that toilets can be a problem, but the number of kids that use the trees as toilets is disgusting. There is plenty of passive surveillance with users and houses facing the park that antisocial behaviour would be minimal.*

*Only that it would be a welcome addition. My son is nearly [- - -] and we are regular visitors. But it's hard to have a decent playdate when you're worried about the toileting issue.*

*Definitely needed. Should have been part of the original revamp of the bike park and play ground.*

*The playground has been established aimed at children aged between 2–5, kids these ages don't have the ability to plan ahead for toileting, so obviously, if an area is going to be offered to this age group, it needs to include a toilet. Otherwise why build it?*

*Try running with a [- - -] year old from Shepherds Bush Park to Barridale Park to get to the toilet in time. Children are going to the toilet in the park and bush which is not a healthy thing.*

*It's long overdue. To expect people to go to another park to use the toilet facilities is ridiculous, especially for young children and grandparents. It is absolutely necessary to have toilet facilities at Shepherds Bush Park.*

*Is it possible to be constructed along the same lines as Barridale Park? i.e.: easily cleaned plus robust/vandal proof whilst still user friendly?*

*For the facilities that are available at this site, a toilet block should have been in the original planning.*

*The toilet 1 km away is too far when you are at a playground with children!!*

*It's always very busy with people who live near and far. The closest toilet facility is 700 m away at Barridale Park and I think it's unfair that parents of little kids either have to walk there or pack all their stuff up into the car just to go to the toilet.*

*The park is well used and with the number of families and groups holding birthday special occasion gatherings, especially on weekends into the early evening, a toilet facility is the only part currently missing. It would complete the beautiful development, there doesn't seem to be a bad element loitering after dark within the car park bike track area.*

*We think it is a great idea to install a toilet facility at Shepherds Bush Park. We support this proposal fully.*

*My kids absolutely love this park and spend hours enjoying the set up. Anywhere set up for kids or with BBQ facilities (encouraging longer visits and get togethers) should have toilets as a standard part of the installation. I can't tell you how many times I have had to pack up and drive down to Barridale park to use those toilets. I would hate to know how much the bush is used in lieu of people using proper toilets.*

*Wow — I didn't realise a toilet block could cost \$120K!*

*I think a public toilet is essential. The park is designed for both young children and teenagers. The little ones are at the age of toilet training so can't hold on long enough to be taken elsewhere. Currently, not all, but enough of the teenagers just go in the bush because there is nowhere else. I agree that it must have doors with timed locks, so it is off limits after dark. The park is a wonderful facility.*

*Most of the time we have to leave this park due to someone needing to go to the toilet, so having one at the park will mean we stay longer and visit more.*

*There are a lot of families using this area, so a toilet would be a popular convenience.*

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*It really should have been included in the original plan when the park was created, especially as it's designed for young children and families to use and enjoy.*

*I have no problems with a toilet facility at Shepherds Bush Park, but my concern would be that the facility could become a zone for anti-social behaviour such as vandalism etc. Will the facility be opened all hours or during certain times only? Who will be responsible for cleaning and maintenance and the associated costs?*

*This is so popular with many ages, it has proven to be very busy and will allow people to stay longer.*

*Great local amenities need to be supported by the necessities. I know Barridale Park it's approximately 700 m away, which is ok. But why not turn the bike park into a fully contained family outing spot? Great work on the park!*

*Very much needed. This brilliant park is always full of families enjoying the bike trails and park. Visitors are always commenting that it seems crazy that there are no toilets, especially when there is a barbeque to enjoy extended visits.*

*We were told, rather than consulted about whole "upgrade", and don't appreciate people, who are not local, coming and whingeing about no toilets when they do not contribute to rates. There are many issues since it was installed, and this will just make things worse.*

*Two toilets.*

*We are at this park weekly and I never understood why toilets weren't included in the last upgrade. This would be an amazing addition, as we have young kids and it's always a hassle when they need the toilet. It usually ends with us leaving the park and going home, which is a shame.*

*Stop kid and adults peeing in the bush.*

*This project was installed without any community consultation. It was then compromised with the former mayor that a toilet would never be installed. This is due to the increased crime and drug use that was historically witnessed at this site, which will be reintroduced with a facility to allow drug taking. As this project is still currently new, it attracts significant non-local traffic to the area. However, when this traffic reduces in time, the site will return to an unsafe zone which encourages drug use within toilet facilities. It has been a frustrating experience for all the immediate residents nearby to this site. The entire ad hoc nature of this project, with safety issues surrounding parking, and the entire facility being closed for maintenance only a couple of months after opening, proves the lack of planning and consultation for this project. We never wanted this here, you never asked to put it here, and now you want to put a facility for drug use near your residents. Just stop. You wouldn't live [- - -] to a public toilet, so why should we.*

*We visit this facility several times a week with our young family (son is now [- - -]). Toilet facilities will make using this a whole lot easier, particularly with young kids who are toilet training or not very good at recognising they need to go to the toilet until the last minute. It would also mean the facility could be used for things such as birthday parties.*

*I take my grandchildren to that park, so my [- - -] can use the skate park and my [- - -] the other great skate around. Very annoying to drive back home or to Barridale Park to use the toilets.*

*Would be so useful with small children!*

*I take my children to this park numerous times each year and would have used a toilet facility if there had been one.*

*A self-cleaning single toilet that doesn't take up too much space.*

*This should be a minimum requirement when you install such fantastic facilities — all events/functions that are authorised in COJ are required to provide suitable amenities, so it shouldn't need a survey, should be done without needing consultation.*

*I believe the installation will allow more community access to the park for the public. Not having those facilities available does deter people from attending the wonderful park facilities.*

*We go to this fantastic park every week, my kids are [- - -] and [- - -] and, without fail, at least one of them needs the toilet each time. It is not practical taking them down the road to the nearest public toilet, because they can't hold it that long. We've had to resort to them going behind a tree on occasion, which I'm not comfortable with, especially when the park is busy.*

*Toilet facilities to have a small toddler size toilet.*

**Do you have any comments about the proposal to install a toilet facility at Shepherds Bush Park, Kingsley? (N = 213)**

*It will finish the park and increase its patronage. Once toilets were installed at Barridale Park the facility boomed.*

*We will be able to [ - - - ] and it is too close to [ - - - ]. It will encourage people to stay around at night and I don't want to feel unsafe [ - - - ]. I think by placing a toilet block with lighting it will encourage people to cause more damage and litter to the park, as well as a real risk of more arson. Please don't install a toilet, or at least move it further to the other side of the park, where it isn't close to people's houses.*

*Have always thought this was what is missing from the site. With small kids, it's hard for them to hold their bladders until they get home. So many kids are peeing in the bushes; a toilet would make sense.*

*Some modern toilet facilities at the park would be great, especially as it does cater for younger children who don't always give us as much notice as we would like. On previous visits we have had to use the facilities at Barridale Park instead. Having the toilets locked at night would also make sense, as the main use of this park is during the day time.*

*Would be great as it would then stop people using the bush as a toilet!*

*Many young children enjoy this park and I've seen parents have to take their young children to the bushes/trees to go to the toilet. My children are in nappies and enjoy riding their bikes here. Once they're out of nappies, I'm not sure we'll be able to continue enjoying the park due to the absence of a toilet. The nearest public one is far too far away to be considered a viable alternative.*

*It is essential. Such a great facility, it needs toilets. I had to avoid going there with my [ - - - ] when I was [ - - - ] because I couldn't get home in time to use the toilet.*

*Much needed for the younger children that play there.*

*Look into getting rid of the people doing drugs in the park before building the toilets.*

*Ensure the toilets lock at night to discourage misuse.*

*This park is heavily used since it's upgrade. Toilets are required to provide relief to the young kids that visit the park and their grandparents.*

*Yes, but make sure the doors are lockable for night time.*

*Our grandchildren absolutely love this park. I hate it when they need the toilet and they have to wee on a tree! It is a fantastic park and especially weekends and school holidays it draws big crowds. It would be so much nicer to have a toilet when required than to find a tree! Please, please give us a loo! Thank you so much.*

*Great idea, it is the only weak point of the facility.*

*Surprised septic tanks are proposed. It seems technically possible to connect to the sewer on Barridale Drive. Surely this is a better outcome for environmental, maintenance and odour reasons?*

*The closest public toilet is more than 700 meters away. As a result, I have been at the park with my son and witnessed several children toileting in the bushes and one adult. This is a very popular park and desperately needs a toilet facility. I'm glad this is being looked at.*
