The company has two directors and provided its organisation structure for the key dedicated management team members supported by three site teams of concreters / plant operators. Resumes for the supervisory positions were submitted highlighting skills, experience and qualifications which were considered appropriate to perform the allocated roles. Details for plant operators were omitted. A comprehensive list of plant and equipment specific to the scope of works, together with category specification, make / model, year of manufacture, type and purpose was sighted. Two full-time mechanics are employed to maintain the equipment. All project personnel are interchangeable between the designated teams due to cross skilling, offering resource contingency. Additional plant and equipment has been allocated of equivalent quality and specification. After hours information was provided for two key personnel.	Dowsing Group Pty Ltd demonstrated extensive experience in providing similar services being listed as a preferred supplier for WALGA (Roads, Infrastructure and Depot Services PSP009) and being the previous contractor to the City from 2015-2018 whereby it conducted kerb and pram ramp removal, saw cutting of asphalt and crossovers, removal of concrete and asphalt crossovers, kerb backfilling, reinstatement of irrigation, supervision and project management for approximately 80-100 streets per year. A list of current and previous contracts was sighted comprising 18 similar contracts for local governments and one for the Public Transport Authority. Project descriptions, contract values and dates were noted for each contract. Details for three additional projects were submitted, two for City of Melville in 2021 (\$21k) and (\$56k), and one for Shire of Ashburton during 2017-2018 (\$590k). References were provided.	The company demonstrated a thorough understanding of the required tasks. It provided detail for how it will schedule the works, conduct assessments to determine the nature and extent of traffic management and how it will notify residents and liaise with the City for existing services information. Works will commence at the requested time with dust emissions mitigated by conducting operations in accordance with its Environmental Management Plan. It will confirm locations of buried services and clarified how it will cut and cap off reticulation and test once reinstated. Plant and equipment to be used was stated. An example project timeline for the works was submitted accompanied by identification and control measures for the major risks which are critical to the project's satisfactory outcome. It provided an extensive list of fleet which included category, make, model, year of manufacture and purpose, which would be available for the City's project, and stated that it has two items of back-up machinery for every specialised machine that is required to complete the project. It can accommodate extra work load with three in-house crews operating. Numerous contacts were provided for outside of hours emergencies.	The company demonstrated substantial experience in completing similar projects providing five specific examples of contracts it has held with local governments with scopes of works comparable to the City's project being City of Melville between 2016-2021 (\$5m p.a.), City of Stirling between 2020-2021 (\$2m p.a.), City of South Perth between 2020-2021 (\$1.4m p.a.), Shire of Mundaring from 2019-2024 (\$2.6 p.a.) and Town of Victoria Park from 2019-2024 (\$3.9m). Numbers of projects, challenges and outcomes were specified within the contract information. The company demonstrated a sound understanding of the required tasks providing its approach to the works which covered most of the City's requirements, including aspects not specifically related to kerb removal. The company will inspect the roads and provide an estimated duration for the project. Whilst it can prepare and implement traffic management plans, this responsibility will be undertaken by the City's appointed contractor. Details for how the company will remove concrete structures once irrigation has been cut and capped were noted including the introduction of alternative walkways for pedestrians and crossovers to maintain service levels. Its methodology covered base preparation for prick paving, back filling and installation of pavement markers / signage. Proposed timelines for elements of the works to be conducted were omitted. It cited six examples of civil maintenance projects it has conducted which mostly included demolition of roads, concrete kerbs and paths for City of South Perth 2020-2021 (\$750k), and 2018-2019 (\$750k), Shire of Peppermint Grove in 2018 (\$120k), City of Stirling in 2019 (\$250k), City of Albany and Main Roads WA in 2019 (\$1m) and City of Perth in 2018 (\$120k). Some of these projects included elements that were superfluous to the City's requirements including reconstruction of concrete paths, profiling, drainage upgrades, tactile paving and asphalt laying. It provided a high level methodology which included the preparation and implementation of management plans with the City locating services and marking prior to the company commencing demolition. Specific details for saw cutting existing driveways were noted with the company acknowledging that it will reinstate the irrigation works and will return to conduct a back fill. Whilst summarised statements were provided covering constraints and contract outcomes associated with the City's previous scope of works, the exact scope of works conducted under other contracts was lacking. Whilst it provided a breakdown of some of the elements of the works to compare with the City's requirements encompassing working adjacent to residential homes, commercial properties and schools, arranging temporary footpath diversion and protecting assets, the exact scope of works was not defined. Three references were provided. The requirement to provide a list of contracts was not addressed.	The company demonstrated a sound understanding of the required tasks. It outlined its methodology whereby it will undertake a site inspection and precondition survey and record the findings. It will review the location of reticulation and cut / cap only those areas impacted by the construction.
